SECTION 1

MANITOBA AGRICULTURE'S ROLE IN ADMINISTERING THE VETERINARY STUDENT EMPLOYMENT PROGRAM (VetSTEP)

Manitoba Agriculture administers the VetSTEP to assist veterinary practices and practitioners in rural Manitoba that provide summer employment to veterinary students who have completed their first, second or third year of studies at the WCVM or other eligible veterinary colleges.

SECTION 2

NOTICE - WHY WE COLLECT PERSONAL INFORMATION AND RECORD OF EMPLOYMENT OF VETERINARY STUDENTS HIRED FOR A WORK TERM BY VETERINARY PRACTICES AND PRACTITIONERS PARTICIPATING IN THE VetSTEP.

Manitoba Agriculture collects from your employer a copy of the Record of Employment (ROE) that they submit to Service Canada when you end your work term and return to your studies. The ROE contains personal information about you that is collected by Manitoba Agriculture, and may be disclosed to Services Canada, for the following purpose only:

• to verify eligibility and administer, monitor, evaluate, authorize and audit VetSTEP program payments to participating employers.

Any other use or disclosure of your personal information must be authorized by you or authorized under privacy legislation.

Where Manitoba Agriculture collects information about you, the collection is authorized under subsection 36(1)(a) of The Freedom of Information and Privacy Act.

SECTION 3

NOTICE – WHY WE ASK STUDENTS TO WITNESS THE ROE FOR THEIR WORK TERM WITH VETERINARY PRACTICES AND PRACTITIONERS PARTICIPATING IN THE VetSTEP.

A copy of the ROE must be submitted by the employer as proof of payment of eligible costs for the VetSTEP. The employer must provide a copy of the ROE to the student <u>prior</u> to submitting its claim for a VetSTEP payment. The information witnessed by the student is used by ARD in verifying the ROE submitted by the employer. ARD may also send a copy of the ROE submitted to the student if further confirmation is required.
