#### Mandate:

The University College of the North (UCN) Governing Council oversees the provision of post-secondary education as learner and community-centred, characterized by a culture of openness, inclusiveness, tolerance and respect of Aboriginal and northern values and beliefs. The Governing Council operates with two advisory bodies; the academic body or Learning Council, that advises the Governing Council on academic issues, and the Council of Elders that provides guidance and wisdom.

## **Authority:**

University College of the North Act

### Responsibilities:

General responsibilities include:

- determine the mission, vision and values of the university college,
- appoint the president and determine his or her term of office and remuneration;
- engage teaching and other staff as required, and determine their duties, conditions of employment, salaries and honoraria;
- · determine the administrative and academic organization of the university college;
- determine which courses or programs are to be offered by the university college, in accordance with the criteria established by the Learning Council,
- determine all questions relating to qualifications for admission,
- approve granting of degrees, honorary degrees, certificates and diplomas;

- exercise internal disciplinary jurisdiction over the non-academic conduct of students, including the power to expel or suspend for cause;
- borrow and invest money required to meet ordinary expenditures;
- enter into agreements to further the university college's purposes, including agreements to develop and deliver joint academic programs;
- establish and collect fees and charges for tuition, and for other services

# Membership:

Not more than 20 members

Up to 10 Members are appointed by the LGIC (Includes Student Representatives)

Other members of the Council consist of: The Chancellor (Non Voting)

- The President
- A student of the university college, selected by the students' association of the university college
- A representative of the Learning Council, appointed by that council
- A representative of the Council of Elders, appointed by that council
- Up to three (3) employees of the university college, elected by the council
- One (1) or two (2) persons who are not employees or students of UCN, appointed by the Governing Council

The chair of the Governing Council is to be selected by the minister, and the members are to select a member to serve as vice-chair. Due regard is given to the Aboriginal composition of northern Manitoba, as well as appointments among women, and those from northern and remote communities.

## **Length of Terms:**

Members:

3 Year Max per Term, 2 Term Max (6 Year Max)

Members may be reappointed, and continue to serve until reappointed, replaced or revoked. Members may not hold office again until at least one year has elapsed since the member last served. A successor's completion of another member's term shall not be considered a term of office.

#### Student Members:

1 Year Max per Term (Can be reappointed)

## **Desirable Experience:**

- experience in the areas of post-secondary education especially the university colleges sector in Manitoba and elsewhere, financial accounting, cultural, social, economic, and labour market issues;
- knowledge of issues specific to the post-secondary education field;
- have the ability to read complex written material, analyze written and verbal information in order to ascertain facts, and apply relevant legislation to this written and verbal information;
- use plain language;
- adhere to a high degree of confidentiality;
- basic technology skill.

## **Time Commitment:**

Full-day meetings are held monthly on the fourth Thursday from September to June. The meetings alternate monthly between Thompson and The Pas.

Remuneration:

Chair: \$250 per month Vice-chair: \$200 per month Members: \$150 per month
