Fiscal Year Occurred	Degree of Injury	Description
2024/25	Major	A client fell sustaining a fracture.
2024/25	Death	A patient experienced an acute change in health status resulting in death. Opportunities for early recognition and intervention were not realized.
2024/25	Major	A patient experienced a procedural complication requiring emergent intervention.
2024/25	Major	Gaps in processes resulted in a diagnostic test not being completed, and led to a missed opportunity for treatment.
2024/25	Major	A patient experienced an acute change in their condition. The opportunity for earlier recognition and intervention were not realized.
2024/25	Major	A patient experienced a change in their medical condition that required a higher level of care. Opportunities for earlier prevention were not consistently realized.
2024/25	Death	Gaps in monitoring led to a fall.
2024/25	Major	Client sustained serious burns from baseboard heater.
2024/25	Major	A patient was prescribed an incorrect dose of medication resulting in an admission to hospital.
2024/25	Major	A resident experienced an injury. Opportunities to mitigate the risk of injury were not fully realized.
2024/25	Major	A patient experienced a change in health status requiring medical intervention after receiving a medication.
2024/25	Major	An incorrect dosage of medication resulted in the need for additional interventions.
2024/25	Major	A resident developed a Stage 3 pressure injury while in care.
2024/25	Major	A patient experienced an acute change in health status after sedation, which required an extended hospitalization.
2024/25	Major	A patient experienced an acute change in their condition. Opportunities to intervene were not fully realized.
2024/25	Major	A complication occurred during a procedure, resulting in need for a second procedure.
2024/25	Major	A patient did not receive their intended medication while in hospital, which resulted in an acute change in their health status, and extended hospital stay.
2024/25	Major	Client experienced a fall, resulting in a fracture.
2024/25	Death	A client experienced a clinical deterioration, following a delay in diagnostic evaluation.
2024/25	Major	A patient experienced serious self-harm after accessing healthcare services.
2024/25	Death	A patient experienced an acute change in their medical condition. Although assessments were provided, the opportunity for earlier consultation and treatment was not realized.
2024/25	Major	A gap in follow-up care, related to medication management, led to a negative outcome.
2024/25	Death	A patient experienced an acute change resulting in death. Opportunities for early recognition and intervention were not realized.
2024/25	Death	There were missed opportunities to manage an acute change in a patient's condition.
2024/25	Death	A patient experienced an acute change in their medical condition. Opportunities for earlier interventions were not fully realized.
2024/25	Death	A patient experienced a clinical deterioration. Opportunities for earlier recognition and intervention were not fully realized.
2024/25	Major	A patient experienced complications following a procedure.
2024/25	Major	A patient experienced an acute change in their condition that was recognized by care providers; however, the opportunity for earlier consultation and treatment were not realized.
2024/25	Major	A resident experienced skin tissue breakdown, requiring increased care and intervention. Opportunities for earlier intervention were not realized.
2024/25	Major	Client experienced clinical deterioration, resulting in transfer to a higher level of care. The opportunity for earlier recognition and intervention was not realized.
2024/25	Major	Client experienced a fall, resulting in fracture.
2024/25	Major	A patient experienced a clinical deterioration after receiving a prescribed medication.
