Misrepresentation of any information as provided on this application or any supporting documentation may result in the Applicant being required to return program funds to EDITNR as well as the in the Applicant being restricted from any future application to this program.

- 1. EDITNR reserves the right to decline Applicants, to determine if products and services are eligible and to determine the scope of assistance.
- 2. The Applicants shall comply with and abide by the rules and regulations of any trade show and local building and trade union agreements.
- 3. The Applicant indemnifies EDITNR from any injury that may arise from negligence on the part of the Applicant.
- 4. If approved, the Applicant will receive up to the maximum amount requested in this application (regardless of final invoice amounts).
- 5. Payment Within 30 days of their return to Canada, the Applicant must submit by email to EDITNR (<a href="mailto:ecdevprogram@gov.mb.ca">ecdevprogram@gov.mb.ca</a>) the expense claim form with relevant invoices and proof of payments for Eligible Expenses claimed along with an filled Evaluation Form.
