- 2. Will the Minister of Education, Citizenship and Youth ensure that thorough and full actuarial modeling is carried out related to the teachers' pension plan and COLA and that this information be provided to the COLA advisory committee to assist them in making their recommendations?
- 3. Can the Minister of Education, Citizenship and Youth tell us if all schools in Manitoba now have a finalized code of conduct in place that addresses bullying?
- 4. Can the Minister of Education, Citizenship and Youth tell us if there is consistency in all of the codes of conduct regarding experiences and consequences of bullying?
- 5. Can the Minister of Education, Citizenship and Youth tell Manitoba why he refused, on three separate occasions, to provide the Opposition with copies of these codes of conduct? Why did he refuse to share this information about how schools are addressing bullying?

- 6. Has the Minister of Education, Citizenship and Youth investigated the excessive violence reported at the R. B. Parker Collegiate in Thompson?
- 7. Is the Minister of Education, Citizenship and Youth giving more than lip services to his Safe Schools legislation?
- 8. Why is the Minister of Education, Citizenship and Youth refusing to fund the Director of Safe Schools Manitoba at a full-time position and why are there no support staff and administrative staff available to Dr. May Hall from the Department of Education?
- 9. What is the Minister of Education, Citizenship and Youth doing to address the crisis situation in the Leaf Rapids Education Centre?
- 10. Will the Doer Government commit to eliminating, in Manitoba their aggressive ad campaigns urging people to gamble? Why are they promoting something they so stridently objected to when they were in Opposition?
- 11. Will the Doer Government follow through with their commitment to fully fund the requirements of Bill (No. 13)?
- 12. What is the Minister of Education, Citizenship and Youth doing to address concerns that there is an identified need for enhanced pre-service training and on-going professional development for practicing teachers in the area of student assessment?
- 13. What is the Minister of Education, Citizenship and Youth doing to address concerns that increased resources are needed in the areas of language training and social services for immigrant and refugee students and their families to ease the transition and integration of newcomers to Manitoba's diverse cultural mosaic?

PROPOSED RESOLUTION:

Mr. DEWAR – Diabetes Strategy

3. WHEREAS in 2001 the total number of Manitobans living with diabetes exceeded 63,000 with over 6000 new cases diagnosed annually; and

WHEREAS Manitoba's aging population has a higher incidence of diabetes than the rest of the population and will further drive up the number of people living with Type 2 diabetes; and

WHEREAS the rate of First Nations people living with Type 2 diabetes has reached epidemic levels, being approximately four times the rate for all Manitobans, and in some regions one in two First Nations individuals aged 50 and up live with Type 2 diabetes; and

WHEREAS the NDP Government has recognized the devastation diabetes has wrought on many communities, particularly First Nations and elderly, as well as the accompanying strains on the health care system; and

WHEREAS the NDP Government has recognized the chronic nature of diabetes and the necessity of formulating an integrated healthy living approach to properly prevent, care and control diabetes; and

WHEREAS Manitoba's diabetes strategy incorporates the Regional Diabetes Program Framework, the Renal Health Outreach Program, the Manitoba First Nations Diabetes Committee and the Chronic Disease Prevention Initiative; and

WHEREAS six million dollars in new funding from the Provincial and Federal Governments has been allocated to fight chronic disease in Manitoba and further supplement previous Manitoba Health and Healthy Living Initiatives that focus on early detection, changes in disease patterns and improved health outcomes. THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to consider continuing to implement Manitoba's Diabetes Strategy by continuing to work with both the Federal Government and community groups in combating in an integrated manner the spread of diabetes; and

BE IT FURTHER RESOLVED that the Legislative Assembly urge the Provincial Government to consider continuing to support public education in the area of healthy living and diabetes prevention throughout the province of Manitoba as part of its comprehensive preventative disease initiative.
