On the Proposed Motion of Mr. ALTEMEYER –

THAT the following address be presented to His Honour the Lieutenant Governor:

We, the Members of the Legislative Assembly of Manitoba, thank your Honour for the gracious speech addressed to us at this Fourth Session of the Fortieth Legislature of Manitoba.

And the Proposed Motion of Mr. PALLISTER in amendment thereto as follows:

THAT the motion be amended by adding at the end the following words:

But this House regrets:

- a) That some Government and all Official Opposition members agree that Manitobans are angry and believe that the Provincial Government has broken their trust; and
- b) That some Government members have concluded that serving this Provincial Government with integrity is no longer an option; and
- c) That these same Government members have said they do not regret speaking honestly as being truthful and holding on to integrity is something that Manitobans have been raised to do; and
- d) That some Government and all Official Opposition members are gravely concerned that priorities may move up the queue based on political interest and ahead of what Manitobans consider to be their priorities and needs; and
- e) That there is a genuine concern amongst some Government and all Official Opposition members that the Provincial Government has become more preoccupied with remaining in power than necessarily doing things that are in the best interest of Manitobans.

As a consequence of these and many other failings, the Provincial Government has thereby lost the trust and confidence of the people of Manitoba and this House.

PROPOSED RESOLUTION:

Mr. Cullen - Princess Patricia's Canadian Light Infantry 100th Anniversary

1. WHEREAS the Princess Patricia's Canadian Light Infantry celebrated its centennial on August 10th 2014; and

WHEREAS the Princess Patricia's Canadian Light Infantry (PPCLI), whose members have served Canada in both World Wars, the Korean War and in Afghanistan, was the last privately raised regiment in the Commonwealth, raised in response to the outbreak of World War I in 1914; and

WHEREAS the history of the PPCLI is inextricably connected with Canada's development by helping to forge Canada's national identity through service and sacrifices in battles such as Vimy, Passchendaele and Frezenberg, among others; and

WHEREAS the Second Battalion of PPCLI, currently located at Canadian Forces Base Shilo, has been stationed almost continually within Manitoba since 1920; and

WHEREAS the PPCLI is one of the most storied regiments in the Canadian Forces and has participated in every major conflict since the beginning of the First World War; and

WHEREAS there have been 1,866 members of the Princess Patricia's Canadian Light Infantry who have died in service to Canada; and

WHEREAS Canada's fallen soldiers gave their lives protecting those who cannot protect themselves, respecting human rights and helping to develop and support the rule of law in countries that have never known democracy.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba officially recognize those who have served their country as members of the Princess Patricia's Canadian Light Infantry and join in celebrating their centennial.
