RESOLUTION:

Mr. WASYLIW – Calling on the Provincial Government to Cancel the Gas Tax Holiday Extension and Bring in Real Solutions for Cost-of-Living Crisis

23. WHEREAS Manitobans are facing a cost-of-living crisis with record increases in grocery store prices and rental housing increases; and

WHEREAS the Provincial Government cutting the gas tax has caused a loss of revenue of \$340 million dollars, being money that was borrowed and added to the provincial debt and deficit that will cost tens of millions of dollars in interest to repay; and

WHEREAS only 43% of the gas tax goes to families while the other 57% goes to corporations and businesses; and

WHEREAS those who need the help the least get the most benefit as many Manitobans cannot afford to drive and see no benefit from this gas tax holiday at all; and

WHEREAS the average driver will see a savings of \$15 a month from the gas tax holiday, an amount of money that could pull 30% of Manitoba residents out of poverty; and

WHEREAS the revenue from the gas tax could pay for free transit for everyone in Winnipeg, Brandon, Thompson and Selkirk; and

WHEREAS the Provincial Government cannot say if rising gas prices are the result of retailers boosting profits during the gas tax holiday as it has failed to monitor gas prices in any real way; and

WHEREAS grocery prices have remained at an all time high despite the Premier's claim that grocery prices would come down as a result of the gas tax holiday; and

WHEREAS the Provincial Government should focus on real concerns such as Manitoba school children having classes in hallways because there are not enough schools in the province; and

WHEREAS 25,000 Manitoba civil servants have voted to go on strike because the Provincial Government will not bargain a fair deal with workers; and

WHEREAS the Provincial Government has done little to address the current climate crisis and transition away from a fossil fuel economy as its approach to the environment is no different than the previous government.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to immediately cancel the gas tax holiday and redirect that money for real cost-of-living solutions for Manitobans.

NOTICE OF MOTION FOR THE NEXT THURSDAY OF PRIVATE MEMBERS' BUSINESS:

PROPOSED RESOLUTION:

Ms. BYRAM – Including an MRI in Portage District General Hospital

24. WHEREAS an MRI is a noninvasive medical imaging technique that uses a magnetic field and computer-generated radio waves to produce detailed images of internal structures in the human body; and

WHEREAS early detection and diagnosis of cancers and other diseases and injuries using MRI not only saves lives, but reduces pressure on the healthcare system; and

WHEREAS there are currently more than 24,000 Manitobans waiting for an MRI scan; and

WHEREAS in the City of Portage la Prairie, a \$450 million state of the art Regional Healthcare Facility is currently under construction; and

WHEREAS the Portage District General Hospital Foundation has generously pledged \$5 million in funding towards having an MRI located at the new hospital; and

WHEREAS having an MRI located in Portage la Prairie's new hospital would reduce the number of people waiting for a scan by approximately 8,000; and

WHEREAS local doctors and health-care professionals support the inclusion in the new construction and have called on the government to do so, describing the lack of scanner as "a glaring omission" that will hurt patients; and

WHEREAS thousands of Portage la Prairie residents have signed petitions urging the government to reconsider and include an MRI scanner in the new hospital; and

WHEREAS having diagnostic imaging closer to home would benefit many surrounding communities and First Nations reducing transportation costs for patients as well as reducing the burden on ambulatory and stretcher services; and

WHEREAS two of the fastest growing communities, Oak Bluff and Headingley, would also benefit from an MRI located in Portage la Prairie; and

WHEREAS wait times for MRIs are up by over 16% in Manitoba in the past year, with hospitals in Winnipeg seeing waits as high as over 46 weeks; and

WHEREAS the invitation from the Member for Portage la Prairie to the Minister of Health, Seniors and Long-Term Care to participate in an MRI townhall event to hear directly from the local community has gone unanswered.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to listen to the calls from over thirty-five local doctors and thousands of community residents to include an MRI scanner in the new Portage la Prairie hospital to reduce wait times for diagnostic imaging and provide care closer to home.
