

**NOTICE OF PUBLIC HEARING
BY THE MUNICIPAL BOARD OF MANITOBA**

**RE: RURAL MUNICIPALITY OF REYNOLDS – SUBDIVISION APPEAL

IN THE MATTER OF: Appeal by Appellant/Owner of the decision of the Community Planning Branch (the “Approving Authority”) to reject the Application for Subdivision of Lot 4 and 7 Plan 63103 in NW 1/4 17-8-9 EPM in the Rural Municipality of Reynolds (the “Proposed Subdivision”), pursuant to Section 129(1)(a) of *The Planning Act*.

PUBLIC NOTICE is hereby given that, under the provisions of *The Planning Act*, C.C.S.M. c. P80, and *The Municipal Board Act*, C.C.S.M. c. M240, the Board will hold a public hearing to hear the Appeal.

The public hearing will take place on **Thursday, July 9, 2026 at 9:30 a.m.** at the **Reynolds Civic Centre, 45030 PTH 11, Hadashville, Manitoba.**

Any interested person may make a representation on the matter to be considered at the hearing. A person who wishes to make a written and/or oral presentation to the Board must register by filing a completed Public Presenter Form with the Board at least ten (10) working days prior to the hearing.

The Board requires that an interested person who intends on filing a written submission must file four (4) copies of that material with the Board, one (1) copy with the Approving Authority, and one (1) copy with the Rural Municipality of Reynolds for public viewing at least ten (10) working days prior to the hearing, failing which copies of the written submission must be provided to the Board and the parties at the hearing.
